## **Slavemaster Mentality: White America's Exploitation of Illegal Immigrants**

Afro National is seeking legal professionals to advise the masses, students to study the law and to write new ones for the operation of the Federation. We seek to soon withdraw from the America legal system by way of nonsupport of it.

**Covenant says:**

- IV. Fostering accountable community-centered policing

**Afro National says:**

Fostering how? Who? Giving account to whom? What the hell are they asking and whom are they asking? The police force in Black communities are out for one thing - to lock-up young Black men - and no policy will change their agenda regardless of what President passes it and what legal ramifications come of it if broken.

Afro National is currently recruiting and implementing a community defense force against the current police state. We are seeking young Black men and women to organize defense groups ready to address any unethical, immoral, or unjust incident that happens again in the Black community because of an overly aggressive cop.

**Covenant says:**

V. Ensuring broad access to affordable neighborhoods that connects to opportunity

**Afro National says:**

If this does not have the stench of integration on it the nose is not working. This is a weak, politically correct plea for Blacks to beg whites to allow them into their communities.

Afro National knows where they are not wanted and do not want to be there. We will build and rebuild our own communities, funded, developed, and constructed by our own people, thus creating our own opportunities.

**Covenant says:**

VI. Claiming our democracy

**Afro National says:**

How can one claim their democracy in a non-democratic country? No thanks.

Afro National has proclaimed freedom and independence already. Simply join and be free.

Afro National wants to strengthen not only the rural roots but most importantly the urban roots and possibly offer freedom to those Blacks caught in the zone of American suburbia that they may regain their freedom.

**Covenant says:**

VIII. Accessing good jobs, wealth and economic prosperity

**Afro National says:**

No thanks. This means being further educated/indoctrinated by their institutions to qualify for their jobs at their businesses and becoming financially dysfunctional like so many Americans rights now.

Afro National will create jobs through a means of production of goods sold to our consumers. We seek economically astute Black minds to develop business and employment networks for Black prospects.

**Covenant says:**

IX. Assuring environmental justice for all

**Afro National says:**

What does this mean, equality in the environment or in the legal system? Huh? Does this have anything to do with Global Warming?

Afro National is based on the laws of nature, i.e., man + woman = baby, understand the earth and the substances in it, and give just due to a man's crime.

**Covenant says:**

X. Closing the racial digital divide

**Afro National says:**

The digital revolution is a trend that will soon die its death because of capitalist greed. The concept is to reach the Black mind through grassroots means, by old fashion print and writing. Visuals leave too much room for stereotypes.

Afro National is seeking writers (from ancient wisdom) to offer up their knowledge in every area of social development. We will pass this knowledge along to the cracks and crevices of every Black community in America.

**Conclusion**

Afro National has just deemed the "Covenant" a threat to the development of the Black community and hereby decree liberation from the ideology of the American political, educational, judicial, and economic system. We seek to build on a foundation of true Democracy from the moral foundation of the Almighty God, the Creator of the universe, and from the written Bond of the Afro Nation Federation.

## **Combating Honky Ideology**

Recent trends in America confirm that racism, in the form of vindictive condescension via public mainstream media humiliation, Jim Crow justice and Vaudeville-type mockery of Blacks is rising and no one, neither Blacks nor whites, know how to impede this rise.

Aframerica says, let it happen; let them call you nigger and practice their racial injustices repeatedly and as viciously as they want because their behavior will eventually blur their logic and perception of their own agenda and thus obstruct their capacity to function logically in the world. As long as they hold power they will impede others from gaining power and to do this they must undermine and taint the images of those others.

Since they have no true understanding of diplomacy - except in the form of monetary and weapon bribery - and they lack the appropriate social skills to gain the authentic respect and admiration from others rightfully, then they will always have that need to keep some people weak that they make look and feel powerful to others and to themselves.

When they exhaust all of their so-called civilized approaches to maintaining power, they will resort to (and have already) the tactic they used to gain that power, which are barbaric in means, and there will be no other way to hold that power except to deplete their armory against resistant powers. We are further studying this phenomenon and believe it will be interesting reading for the world in the future.

Honky Ideology is our stipulated definition of this social degradation of humanity, including Blacks and the treatment of other people of color, by the Anglo Saxon race. Honkyology, therefore, is the study of the origins of, and the rise and fall of Anglo-Saxon thought.

The Saxons, who settled in England in the fourth century amongst the Romans and Germanic tribes, struggled for power and control of Britain, but the Christian-based Romano-British held tight to power and expanded the Christian empire, yet incorporated much of the Saxon paganisms. The Saxon-British confession to Christianity will make this task that much easier to uncover.

Furthermore, their impending fall will of itself be brought forth by the very confession to Christianity they proclaim. So, historical records will reveal that this will be the first people in history who will destroy themselves using a form of religion they obviously never really understood Christianity, which originated in the northern areas of Africa and the middle east, was never a white religion, but in time was adopted by the Roman empire as a form of worship because they had no God except for the mythological gods of Greece, who were in fact, not real.

True spirituality confounded the Saxons for decades before they accepted Christianity as their own, but not without blending forms of Anglo-paganism into the newly found religion. So, the fact that many whites have no real understanding of the principles of a religion they claim to champion - as seen through their acts of racial hatred toward other cultures - should be no surprise to Blacks or other world cultures who know their history.

The fact remains, they had no understanding of Christianity from the start; they only took what other cultures knew as sacred and twisted it to fit their own ideology. In Honky Ideology, a Honky is a person of Anglo-Saxon heritage and low spiritual aptitude who professes to be a God-fearing W.A.S.P. or White-Anglo-Saxon-Protestant., yet perpetuates and celebrates the concepts and practices of Anglo-paganism in addition to being taught and believing that the God of Christianity has exalted their race as superior while looking down their noses at others and, therefore, gives them divine right and the social privilege to have first claim to the world's resources and some form of intellectual preeminence over others.

Their ideology of life is a conglomeration of ideas on world domination through governmental, military, judicial, religious, and social control over others in the world. For some reason, they believe that their ideologies are better than any other ideologies ever conceived which in turn gives them the right to enforce these ideological concepts on others.

In terms of others, they believe that all other cultures and peoples of color other than white are somehow barbaric, ignorant, uncivilized or incapable of surviving unless they adopt the ways of Anglo-characteristics. Thus we have the term, Honky Ideology. In America, at current, whites are at odds on who to hate.

Some hate the Blacks, some hate the Jews, some hate the Muslims, and some now hate the Hispanics. Regardless of which minority group happens to be in the news media, whites will find a reason to hate them because they are considered an intrusion into their supposedly privileged and gated lives. And regardless of what class whites belong, they feel they have to protect their interest and or standard of living from whomever.

They cunningly campaign for the future of their children, which actually means protect us from them; whoever they are, and they secretly seek to preserve their race and the whiteness of it. It doing so, they must pinpoint any and everything that is not like them and tag it (or stereotype it) in the media so everyone else of their own can know what is not like them.

They must maintain power and control of all the country's economic, social, and educational institutions as well as political, judicial, and medical institutions in order to better themselves over others and protect all their interest. When anything becomes a challenge or threat to their interest, they have to destroy it completely or slowly, depending on who the threat comes from.

In the case of Blacks, because Blacks have always been here and have learned their ways and understand the religion, even better than they themselves, whites have to continually attack Blacks and their image. And because Blacks are rising in many areas of social positioning and influence, they will target that area and launch a campaign against it to make others, even Blacks themselves, doubt themselves.

The strategies of white oppression and humiliation consist of many tactics and one most prominent tactic against Blacks is discrimination. Since slavery and Jim Crow, the country has been sort of quiet because there was no blatant racism going on, but now racism is rising again because of 9/11 and immigration, but somehow, whites have found a reason to take it out on Blacks even though it is Islamic radicals that want to kill them and it is Hispanics that are draining their resources.

However, anyone in the world - if they had a brain of their own - could see that the media were revealing what racists' they truly were. Nevertheless, the reporters and anchors unfortunately do not have the intellectual ability to understand what they were doing was making complete ass-holes of themselves.

The reports streaming in from New Orleans during the week-long travesty were over exaggerated, full of lies, and racism. The media has yet to admit to all the lies, hypocrisy and inaccuracies they reported, but who could actually expect them to through all the arrogance and supremacist mentalities that control American media. However, what truly happened people have to read else where or hear from the victims themselves.

CNN warned that there were "bands of rapists, going block to block." Snipers were reportedly shooting at medical personnel. Bodies at the Superdome, we were told, were stacked like cordwood.

The Washington Post proclaimed in a banner headline that New Orleans was a "A City of Despair and Lawlessness," insisting in an editorial that "looters and carjackers, some of them armed, have run rampant."

Fox News anchor John Gibson said there were "all kinds of reports of looting, fires and violence. Thugs shooting at rescue crews."

Meanwhile, the distortions, exaggerations and flat-out fictions being offered by New Orleans officials were accelerated and amplified by the media echo chamber.

Glib predictions of 10,000 dead, and the chief of police's insistence that there were "little babies getting raped," swirled around the media like so much free-flowing sewage.

Reports of the Superdome being a slaughterhouse were repeated, even though dozens of news organizations had access to the building.

CBS alone had 200 people in New Orleans, and yet it couldn't find those bodies stacked to the ceiling or a single rape victim from the roving bands of "Mad Max"-style marauders. That's because nobody was raped or murdered in the Superdome.

### **Scant News on Katrina Family Recovery**

The National Center for Missing & Exploited Children (NCMEC) for its work in locating and resolving the 5,192 children cases of displaced children as a result of Hurricanes Katrina and Rita. In the months following Katrina, the non-profit NCMEC received reports of 4,710 children missing or displaced from Louisiana, 339 from Mississippi, and 39 from Alabama. After Rita, another 28 children were reported missing or displaced from Louisiana; 76 were reported missing from Texas.

The most serious cases were those children arriving at shelters without adult supervision. A total of 45 unaccompanied children were "found" and reported to NCMEC; by October 7, 2005, all 45 cases were resolved.

In addition to reports of missing/displaced children, approximately 12,342 missing adults were reported to NCMEC's Katrina/Rita Missing Persons Hotline and referred to the National Center for Missing Adults (NCMA).

There has been little news coverage of reuniting Katrina families, where the children are, or if there are still any efforts going on to reunite families of Katrina. Most websites that began after Katrina to search for the missing have been shut down or discontinued. When Katrina anniversaries arrive yearly, there is little talk of how many children have been found and reunited with their families.

In addition to little coverage of the families, there remains no official death toll for Katrina, nor has there been mention of whether or not any remains are still being found. The only coverage about Katrina today is how much money has been spent, how much was wasted, and how insurance companies are faring after the disaster. And most of the slant is toward favoring the insurance companies with much negative mention of Blacks who supposedly robbed the system by fraud. Thus the racism continues in various forms.

Sure, there are efforts to rebuild New Orleans but the outcome does not look promising, especially for Blacks. Though most victims of Katrina have reestablished their lives elsewhere and would rather not return, those who have continue to catch the brunt of humiliation from negative news coverage of Black life in New Orleans. The racism of this event continues to be phenomenal and should convince all Blacks in America of what we are up against.

If there is one Black person who does not see the continued practice of American racism in this story they are truly beyond brainwashed and should be stoned for having no mind of their own. Below is another montage of Katrina related news that surfaced after the storm.

Further revelations of Katrina racism shows that the storm itself was not the true cause of the New Orleans catastrophe, but broken levies were. The government neglect and irresponsibility of those levies have been underreported, nothing has been done, and again, instead of whites taking responsibility and owning up to their mistakes, they find ways to redirect the topics away from government failure and once again lay it on Blacks.

The energy it has taken whites to keep the topic of this story on Blacks and their shortcomings must be exhausting. But we now see that that will not stop the drive of hatred and racism toward Blacks in this country from revealing how whites truly feel. The lies have not stopped and they are continually fanned by racist and misguided people in the media and in the America population.

**Katrina Truths**

Myth: Katrina was a devastating, once-in-a-lifetime storm, the likes of which had never been seen before.

Fact: Nothing about Hurricane Katrina in and of itself was atypical, except for the 30-mile hurricane radius. By the time the storm made landfall in Louisiana, it was a mid-level Category 3 hurricane that already had touched down in Florida three days before. The National Hurricane Center in Miami has reported that due mainly to rising sea-surface temperatures in the Atlantic Ocean, the cycle of rapidly forming hurricanes could last for up to 40 years, making storms like Katrina all the more common. Thus, it's highly unlikely that Katrina is "the big one" that has been predicted since Hurricane Betsy in 1965.

Myth: Most New Orleanians ignored the evacuation orders, choosing to stay behind and take their chances with the storm.

Fact: Despite FEMA promising transportation assistance 48 hours before any recognized hurricane and lacking the emergency assistance registry implemented in Florida, 90 percent of southeast Louisiana residents were successfully evacuated from the Greater New Orleans area in less than 24 hours, even after being left up to their own devices. The remaining 10 percent - mostly poor and elderly - were ushered into to the Louisiana Superdome, a structure that had seen refugees from Hurricane Ivan in 2004 and Georges in 1998. The pre-Katrina evacuation is one of the most successful evacuations of a major city in American history, with everything more or less going down according to plan.

Myth: Nagin left more than 2,000 buses to waste during the hurricane, instead of driving people to safety.

Fact: According to the New Orleans Times-Picayune (Sept. 5, 2005), Orleans Parish school district owned a mere 324 buses; 70 of them didn't run. Additionally, Nagin's jurisdiction was only in the city of New Orleans; had he boarded citizens onto the buses and found enough people capable of operating them, there was no guarantee that they would have been allowed to stay wherever they stopped. Scores of citizens, tired of waiting for government intervention, set off on foot over the Crescent City Connection bridge, only to be turned back by gunpoint by the City of Gretna Police.

Myth: Shortly after the hurricane, New Orleans fell into anarchy, with the Superdome becoming a haven for rape and murder. Babies with slit throats, rapes in the Superdome, citizens turning to cannibalism, unidentified bodies piled up in freezers.

Fact: The reports coming from all over the devastated area, including from Mayor Nagin and Police Chief Eddie Compass, sounded too horrific to be true - and they were.

The Louisiana National Guard reported six deaths in the Superdome: one suicide, one drug overdose and four natural deaths - or as natural a death as staying in a football stadium for nearly a week with no food or water can cause. The Guard also confirmed that there was no shooting at planes, no drug addicts robbing hospitals, and only one police officer shot (with his own gun) during a struggle.

When 42,000 New Orleanians were evacuated from the Superdome and the Morial Convention Center on Sept. 3, Lt. Gen. H. Steven Blum of the National Guard Bureau, reported that "there was absolutely no opposition." Sgt. 1st Class Jason Lachney, who helped out with Superdome security, said of the anarchy stories: "I think 99 percent of it is bullshit."

Myth: Many Hurricane Katrina victims squandered the money given to them for relocation, resulting in billions of wasted dollars.

Fact: It's true that billions of dollars were wasted in less than four months, but the cause had little to do with the emergency assistance funds given to Katrina evacuees. Once again, FEMA would bring the word "wasteful" to a whole new level: more than 10,000 trailers left to sink in mud; roof tarps that run less than \$100 in hardware stores being [being purchased for] listed as \$2,500 apiece; evacuees being placed in \$400-per-night hotels; and so on.

Even the exaggerated cases of debit card/emergency relief check fraud were due largely to government error.

Nearly half of the 11,000 debit cards (which were only issued for three days before the program was halted) were sent to people who'd already received their funds via electronic balance. The Houston Police Department Fraud Task Force confirmed that the majority of the money was spent properly and, compared to 23 families in Hancock County, Miss., living on a cruise ship that cost the government \$1,000 per day, debit cards used to buy rims and jewelry were hardly making a dent in the category of wasted funds.

According to reports, "Personal income decreased \$29.1 billion, and stands at (-) 2.3 percent, and disposable personal income (DPI) decreased \$10.5 billion in February, 2009, down from (+) 6.9 percent in first quarter of 2007, according to the Bureau of Economic Analysis." - Bea.gov.

In other words, more people are making less money yet the cost of living continually grows higher. The credit crunch requires tighter credit standards, so does buying a new or even used car. College tuition is up and healthcare cost is ever rising. Yet, jobs are scarcer than ever and outsourcing is encouraged by United States policy makers and businesses. How can people take individual responsibility for this?

The poor are those whose land was not yielding fruit during certain seasons, which forced them to depend on the authority of the time. God always looked after the poor and monitored the behavior of the rich toward them.

In America today, widows, fatherless, strangers and the poor face dire situations against the face of power because prosperity, wealth, and credit worthiness are such high priorities that society has little patience

for anyone who cannot compete. Each of the above groups are somewhat disadvantaged today if they have not seized on any mainstream opportunities to success.

American society tends to either lock the disadvantage out entirely or smugly dispenses aid and or charity leaving the disadvantaged to unfriendly and sometimes hostile private corporate business practices and policies that seek the business of middle to upper class families and the wealthy instead. Though government designs programs that supposedly assist the poor and lower income, the rate of return far outweighs any benefits advanced to the poor.

When single mothers work two jobs to survive: pay for childcare, food, housing, transportation, utilities and clothing for her and her child, on a salary barely enough to get by, she has no real life, but is in debt to society being used to further the growth and operation of a system that benefits the wealthy only more each day. When children are legally deprived by the courts of the right to their fathers, and are made to believe that their fathers are the enemy, we live in a society no longer in favor of the fatherless, nor the widows, but of bureaucracies and corporate interest.

American society has fallen to the point of cataloging the underprivileged more as criminal than disadvantaged and underserved. And as their hearts harden, the gap widens between the haves and the have-nots.

## **The United States Government War on Black Men**

This issue is irrefutable. The continuous systemic operation to immobilize the progress of Black men in this country is an undeclared, publically unaddressed reality, and no one dare correct it because of the twisted psychological propaganda instilled in whites, other minorities and even the Black population itself.

According to studies, "the effects of previous incarceration and strict child support policy enforcement on the labor force behavior of young black men. We find that past incarceration is strongly and negatively associated with such behavior. We also find some evidence that child support enforcement limits labor force activity, especially among those age 25-34. In fact, our results imply that past incarceration and child support can account for most of the declines over time in labor force activity for this age group, though somewhat less among those age 16-24."

If anyone seriously believes that Barack Obama is a means to the end of the disproportionate ill-treatment of Black men in this country, they are seriously deceived. Barack Obama will only do what is in the best interest of the whites who helped promote him to this current status, and who would just as well make sure the populous of Black men remain stagnant.

With help from additional white-washed so-called Black leaders, the United States will continue its terroristic reign on Black men because everyone would rather feel safe in knowing the Black man is being systematically constrained than search for any humanistic trait in themselves for seeing Black men as normal citizens.

It is a damn shame that people, especially Black women, feel the need to punish Black men simply because they are the chosen stock of people to cast as dangerous to society; chosen by government forces to treat as an example to others and as a commodity used to employ white suburban dwellers, feed their families and fund their college education, while at the same time, stripping Black men of equal rights, opportunities, and their natural-born right to life, liberty, and justice.

The United States government is the most hypocritical, low-down, and dirty Black men haters in the world and will soon suffer for the intentional underdevelopment and mistreatment of a people who had no chance in obtaining success in a country built to serve whites only and who have suffered at the hands of white hate from the day they arrived in this country.

Even some of themselves know the treatment of Black men is wrong and have put forth a plan to stop the injustice or at least curb it. Below are solutions presented in the study:

Beyond programmatic efforts, some broader policy changes might be needed to address the negative effects of incarceration and child support policy on employment of young black men. Regarding incarceration, policymakers at the state level should review the barriers to employment that they generate for ex-offenders, perhaps distinguishing those that are sensible from those that are strictly punitive and perhaps counterproductive (like drivers' license revocation and other bans on occupational licensing for those with criminal records).

Efforts to link ex-offenders to the private-sector labor market should begin while they remain incarcerated, by lessening restrictions on the ability of private employers to use inmate labor, especially in tight labor markets. And the use of other tools, such as federally sponsored bonding and tax credits to employers, should be explored further as well.

Regarding child support, states should be encouraged and assisted in efforts to review the practices by which child support orders are developed for low-income men- often without any direct evidence of their potential earnings. Arrearage forgiveness efforts need to be explored for non-custodial fathers who make a good-faith effort to keep up with current orders-especially if arrears have accumulated while they were incarcerated or otherwise unable to work.

## **Nonviolence as a Strategy against a Violent Oppressor**

Personal restraint as a first reaction against physical, aggressive or even verbal abuse is difficult under such temptation. Black America have lived in America hundreds of years under these type restraints; physical, mental, and emotional. Not being able to express ourselves accordingly against the many injustices we face.

Threats of imprisonment, death, and social exclusion are a few of the punishments we face if we decide to react in anyway other than the systematic process we have been given, such as police reports, grievances, law suits, appeals, and other bureaucratic complaint procedures, even though these procedures do little to address our deep-seated problems with America.

In a society where the ruling party has sole sovereignty to prescribe punishment, anyone, culture, or people contrary to governmental operating procedures, can face anything from hasty and false imprisonment and confinement, death by authorities, false accusations, and even forms of legalized torture, and not being able to properly react to such ill-treatment can take a serious toll on the psyche and emotional state of certain groups of people over many years.

Blacks have many times protested, marched, voted and even rioted to bring attention to what they believe were social injustices, and many groups and cultures today react to injustice the same way. We all, regardless of what race, religion or sexual orientation, have learned that to resist U.S. authority could mean death. So personal and group restraint have become learned behavior living in America.

Nonviolence is the term and practice all are indirectly forced to use against aggressive authority. It is a biblical concept that Jesus taught his disciples and that many other religious leaders in the past have used as a means to fight against their oppressor, as opposed to complete social rebellion. In America's past and

Black American's fight for civil rights, Dr. Martin Luther King used a nonviolent strategy as a method to gain those rights. He realized violence was not an option.

The Black Panthers and many other militant Blacks and rebellious slaves down throughout history learned the hard way that violence against a nation of such staunch believers of white supremacy and a massive army as the United States Government, was suicide at the least and many also learned that judicial sabotage, social confinement, and even exportation from the country were also used to rid the country of such rebels.

Today Blacks and many others face this same fate. Regardless of the injustice done or by what means authority decides to prove their point or make an example, anyone who resists and stands up will face harsh, even deadly force organized by white supremacist groups, pro-white collectives and laws, all sanctioned and backed by the United States Government.

In such a climate, we should all learn why nonviolent resistance may possibly be our only way out. However, in order to win the war of injustice, we have to understand how the nonviolent strategy works, what it does and how it has an affect.

### **Philosophy on Nonviolent Resistance**

During the civil rights movement, Martin Luther King Jr. captured the attention of the nation with his philosophy and commitment to the method of nonviolent resistance. According to Dr. King, this was the only solution that could cure society's evil and create a just society. As King emerged as a leader in the civil rights movement, he put his belief into action and proved that this was an effective method to combat racial segregation.

### **Nonviolent Resistance Awakens Moral Shame**

Second, the point of nonviolent resistance is not to humiliate the opponent, but instead to gain his friendship and understanding. Further, the use of boycotts and methods of non-cooperation, were the "means to awaken a sense of moral shame in the opponent."(3) The result was redemption and reconciliation instead of the bitterness and chaos that came from violent resistance.

### **Nonviolent Resistance is a Battle Against Evil**

The third point King advanced was that the battle was against the forces of evil and not individuals. Tension was not between the races, but was "between justice and injustice, between the forces of light and the forces of darkness. And if there is a victory it will be a victory not merely for fifty thousand Negroes, but a victory for justice and the forces of light."(4) Thus, tension only existed between good and evil and not between people.

### **Nonviolent Resistance Requires Suffering**

Fourth, nonviolent resistance required the willingness to suffer. One must accept violence without retaliating with violence and must go to jail if necessary. Accordingly, the end was more important than safety, and retaliatory violence would distract from the main fight. King believed that by accepting suffering, it led to "tremendous educational and transforming possibilities" and would be a powerful tool in changing the minds of the opponents. (5)



### **The Nonviolent Resister is on the Side of Justice**

King's fifth point about nonviolent resistance was that the "universe was on the side of justice." Accordingly, people have a "cosmic companionship" with God who is on the side of truth. Therefore, the activist has faith that justice will occur in the future.

### **Nonviolent Resistance Rests on the Power of Love**

King's sixth point was central to the method of nonviolent resistance. He believed the importance of nonviolence rested in the fact that it prevented physical violence and the "internal violence of spirit." Bitterness and hate were absent from the resisters mind, and replaced with love.

### **Agape Love is a Redemptive Love**

However, the kind of love King was talking about, was not the affectionate type, but instead the type that meant "understanding, redeeming good will for all men." He further explained that in the Greek New Testament there were three words for love and each had a different meaning. Eros was romantic love and philia was a reciprocal love. Neither of these two types of love were the kind that King advanced. Agape, which was not a passive love, was the kind of redemptive love he referred to. According to King, "It is an overflowing love which is purely spontaneous, unmotivated, groundless, and creative. It is not set in motion by any quality or function of its object. It is the love of God operating in the human heart."(6)

Overall, nonviolence is the strategy of having faith in something higher than what we fight against daily. As difficult it must be to not see yet believe in something that does not seem to make an appearance in our defense, it has become and always has been the oppressed way of enduring oppression. Oppressed people are often forced into a realm of hope, trust in the unknown, and a deep sense of the desire for vengeance.

To allow hatred to eat away at the heart causes misery for a lifetime and distorts judgment from day to day. We must see our vengeance each day in forms the oppressor cannot see, such as folly in their thinking, faulty logic, immorality gaining strength in their lifestyles, violence and murder as their only means to ruling, which are all weaknesses and against natural law, love, and humanity. We should see these as victories instead of dwelling on our losses.

There is no love in oppression, control, or violence as a means to control. We personally know this by the past relationships we have all had. We could never win a race war if it comes to hand-to-hand combat against angry white rebels because we would eventually have to face the courts and the U.S. Armies. We may handle urban combat and battles to a point, but winning the war against such violence would be difficult if not impossible.

However, anything is possible if we look beyond what we see and focus on what we do not see, which is a God with a force of vengeance that we could never unleash. Disease, famine, natural disasters and hatred from outside forces have always been a type of war strategy with God. God never enacted war for the simple pleasure of having war, God sent his soldiers into war when there was a nation of people who openly defied him and his laws, and who worshiped other gods; such is the case with the United States. They have openly defied God and are soon to reap the rewards of discrimination, injustice, murder and false witness.

So stand down and adopt the nonviolent mindset. In the end, though we have suffered massive losses physically, emotionally, and psychologically, we do have hope in the chance that there is something greater than our oppressor.

## **The 7 Sins of Materialism**

Only a mind capable of perceiving the needed level of clarity when interpreting the metaphoric meaning of a "thin line" can understand the difference between materialism and modesty. There is no sin in having nice things; and having nice things and having a nice life are extremely dissimilar though often interpreted as one. But the true test of character is revealed during the battle of possession between the owner and the things. Does a person own their things or do the things own the person?

Material things are actually only a figment of our imagination; tangible substances in a world long passed away. We are merely spirits subconsciously living our lives through lust of the flesh. Once we awake, we will see nothing of substance but only an image of ourselves after we have lived; and that image will tell our life story. Whether bits and pieces of our heart and soul were torn from within our person in a desperate struggle of control, or whether we are in full possession of our being; our love, dignity, and most important, our loved ones.

Despite the beautiful glisten of a diamond or the allure of stylish fashion, we live in an ugly world. Seductive, illusive, deceptive: seductive because we are a wanting creature; always wanting more or something different. Illusive because many times we only think we are happy or satisfied with what we have; and deceptive because we have to fight daily to maintain a sense of humanity through a barrage of vanity. To emerge victorious from such a hell, we must learn to overcome the most powerful weapons of the force that seek to leave us beaten. The 7 sins of materialism:

1. Lust - can be modishly translated as desire, which most people view as harmless. And this is the first form of deception when recognizing the "thin line," because desire is nothing more than an acceptable form of lust. The paradox comes in understanding what things are acceptable to desire. Tangible things satisfy only temporarily and as long as they are in a person's possession. So the belief that anything tangible will complete life is wrong; it may make life better but can never complete or fulfill it. If a person's life consists of gathering or doing things as a means to fulfill life, or make it better, they are deceived because the fulfillment of one person's life always means the neglect of another. Therefore, lust can only be beaten by desiring the best for others.
2. Idolatry - the admiration of or worship of something material or an obsessive adoration for another person. To own and use is one thing but to have for show is another. If a person feels the need to prove their worth by having the best, then their dignity is worth little because they would be easy to hurt when they have little. In comparison, to live and die for is one thing but to place one above all others to

serve with a motive is another. True love is not easily impressed by the possession of or association with mere nouns, and if a person is required to possess nouns before gracing the presence of another, that other will always be easy to disappoint and never satisfied. Therefore, idolatry is overcome by pretending to not be impressed, and really not be.

3. Hatred - crosses lines, penetrates walls and cuts deep. In the context of materialism, hatred is a fusion of jealousy and fear. Unlike envy, however, (jealousy's unruffled cousin) jealousy is more aggressive and when mixed with fear usually brings forth action. Whenever a person lacks something someone else has, whether materially or characteristically, that person experiences a series of emotions leading them to question their worth in the eyes of others. And if that person has not met expected goals, they become defensive, delusional, and succumb to deep self-evaluation. Unconsciously, they irrationally compare themselves to others in terms of possessions and accomplishments, which lead to diminishing the achievements of another. Once these actions have manifested they have officially become a hater. Therefore, the way to resist becoming a hater or dispensing hate is to appreciate your accomplishments and respect the accomplishments of others.

4. Variance - a difference between conflicting facts or claims or opinions; "a growing divergence of opinion." On an individual basis, people tend to seek individualism and stray from the norm regardless of the consequences cause disruption. Many church organizations have experienced high levels of variance, which is why there are so many different church denominations. Men have learned to disagree more than agree on certain things. This is sinful because it ruptures any real truth, places too much emphasis on individuals and their ideologies and distracts from community similitude. When people seek differentiation, they often bring dissension and controversy within their particular group setting, whether family, work related, or community, all efforts of variance away from traditional norm, especially tradition that has always worked for the best, usually brings division. So to minimize the spirit of variance, one has to simply acknowledge and agree to follow truth and tradition; because there is actually only one truth.

5. Emulation - effort or desire to equal or excel others. Compelled by the force of arrogance, emulation reveals a hatred of self and an extreme adoration of someone else. Copying is a low-level form of emulation by which one performs the characteristics and mannerisms of another, whether individual or group; trying to be something or someone one is not. A wolf in sheep's clothing is a perfect example because though the wolf looks and acts like his prey, the true inward traits of his victim is not really there and those who personally know his victim can recognize the fraud. Other examples span across culture and gender. The true nature of a person is eventually exposed during certain situations. The only way to defeat the spirit of emulation is to know one's self and acknowledge and respect others for who they are. Also, most people who are emulated want to be and encourage it, which is also sinful because everyone should want others to be who they are and not them.

6. Envy - discontent or covetousness with regard to another's advantages, success, or possessions. Envy causes a person to react in negative ways toward others. Their perception of right and wrong is distorted and instead of rewarding the person they envy, they punish them in a series of pessimistic ways. This reaction tears a relationship down when, instead, this is a time to use another's success as a positive and for self improvement. Many potential relationships, business ventures, and even nations have fallen by the rod of envy. And as emulation, on the opposite side of the coin, people enjoy being envied and often entice others with their successes. Throwing it in their faces initiates envy and is just as sinful as the

act of envy itself. To avoid envy, one has to count the successes of others as social constructiveness and to always be content with their own lives and possessions.

7. Revel - to take great pleasure or delight and or to indulge without restraint. Not many people realize that regular or continuous celebration is considered sinful because it leads to too many other actual acts of sin such as drunkenness, fornication, and sometimes violence. Moderation is the key to enjoying life, not over indulgence. The over consumption of luxuries, attention to sport, and constant festivity eventually weakens the mind placing the person in an almost permanent state of indifference to anything meaningful or important. Many people have lost motivation, drive, and or desire to move forward, try new things, or even complete a goal because of the spirit of revelry instilled into their actions. To overcome and remain on solid ground, one has to have a clear understanding of reality and know that there is a time for everything under the sun.

Many people remain balanced in their lives and have not succumb to the temptations that lead to the seven sins of materialism, but as times change and social standards gain strength over traditional integrity, many have fallen victim to one or more of the sins, and some deeper than others. The more a person allows themselves to become enslaved by the grip of either of these sins, the worse their life becomes because they are now living more of an illusion having become detached from reality and truth. One does not have to live these sins because they always have the option of defeating any one.

To simplify a surefire way to defeat each of the seven sins without fighting each individually, there is only one power that can defeat all while responding to each in every situation. Love is the key. If a person lives from the root of love in their hearts, love covers a multitude of sins at all times. Love, defeats all the seven sins of materialism and them some. No science, medicines, herbs, or counseling can protect against sin nor cure it, but just as sure as these seven sins exist that drive people to react; only love is the cure. ## **Organized Slavery in a Free Market**

The American economy is based on the monetary theory of capitalism; the Free Market system of entrepreneurship and free will choice. However, the current economic meltdown in America has placed that theory in question.

Capitalism is a workable system because it operates in a reciprocal rotation dependent on human labor, distribution of resources, and the consumption of the resources by the public in terms of needs and purchasing power. The cycle has to continue almost uninterrupted on every side for the system to thrive effectively, yet the slightest interruption could break the cycle causing the engine to stall and possibly crumble.

"The Invisible Hand" is a term coined by Adam Smith, the Scottish moral philosopher and economist who says 'the natural force that guides free market capitalism through competition for scarce resources. According to Adam Smith, in a free market each participant will try to maximize self-interest, and the interaction of market participants, leading to exchange of goods and services, enables each participant to be better off than when simply producing for himself/herself. He further said that in a free market, no regulation of any type would be needed to ensure that the mutually beneficial exchange of goods and services took place, since this "invisible hand" would guide market participants to trade in the most mutually beneficial manner.'" - Investorwords.com.

In so many words, the Free Market is supposed to take care for itself and in slow times self-correct without intervention of any outside forces such as government or certain individuals with any self-interest in the market. Self-regulation of the economy, in theory and practice, would work if fair business ethics, protection of the worker and consumer, and respect for the social structure of family and community were involved. If any of these three basic principles are violated in any manner, capitalism can turn ugly and in a most negative direction.

Monopolies are an enemy of Free Market capitalism. Businesses such as Wal-Mart and Microsoft, that acquire large shares of the consumer market makes it harder for smaller businesses to compete and make money. Monopolies also gobble up workers and marginalize the pay scale to a base-line rate. This, in turn, limits the purchasing power of workers and families, initiates a wage-earning and class divide, and as a result, more businesses make less money; and the cycle continues until one or the other entities are of no value and/or soon depleted.

Of course, greed is a part of human nature and has proven to be much stronger than the concepts of sharing and equality. Capitalism, in its raw form, intensifies the human spirit of greed thereby canceling out sharing and equality. On this fact, when monetary power rests in the hands of the greedy, they are naturally driven to become wealthier, disregarding the needs of the public. Afterward, indifference, selfishness, and apathy become social mores'.

As the spirit of greed permeates society, it fuels materialism, which brings on over-consumption of unneeded goods and heightens individual arrogance and indifference toward anyone unable to meet the materialistic demands of society. Once this covetousness spirals out of control, those who are able to reap the rewards of capitalism tend to blame the less fortunate for their situation and for any problems entrenched in society as a result of the economic divide between rich and poor that capitalism produces. In other words, people become puffed up and big headed and forget where they came from.

In theory, "Smith believed that while human motives were often driven by selfishness and greed, the competition in the free market would tend to benefit society as a whole by keeping prices low, while still building in an incentive for a wide variety of goods and services. Nevertheless, he was wary of businessmen and argued against the formation of monopolies." - Adamsmith.org.

In reality and as a result, this capitalist greed and the immense appetite and consumption of the rich, American manufactures export jobs overseas to increase profits thus taking jobs from the homeland. Furthermore, companies gouge consumers and freeze wages making it harder for families to survive and grow economically. In addition, the banking and credit systems, the dispersion of natural resources and ineffective, out-of-touch politics has brought the concept of the American Free Market to the point of collapse.

In America's consumer-driven economy, low-wage labor in the face of abundant goods and services that feed humanity's unquenchable desires, are no match for the temptations of easy credit, deceptive schemes and promises of wealth and riches. From credit card companies to mortgage brokers to pyramid schemes and churches, the greed for wealth has overshadowed the basic principles of human need. So, when found wanting in a so-called thriving economy offering unlimited opportunity to wealth, the average person falls as victim to the powerful.

For decades, America has operated on the assumption that the Free Market system is feeding the entire population equally and all are profiting from its effects. But in reality, a growing gap between the rich and the poor is the result. As the cost of living rises over the years, wages do not rise fast enough thus forcing people to purchase on credit, which afterward have driven up the debt-to-income ratio among millions of families. The higher the debt, the less often it is collected by the lending institutions and the higher the risk those institutions take.

To solve this problem of inequality, advocates for consumer and worker rights have petitioned the government to intervene and possibly regulate monopolies and big business. Instead of approaching the problem from the opposite side of the spectrum, from the side of the people, society, including government politicians, lobbyist, and the courts, believes the answer comes from empowering the very entities that are dispensing capitalist poison; the businesses, in hopes that a trickle down effect will refuel the economy and re-empower families.

Instead, labor unions that once protected the worker have disappeared; consumer protection in the courts have taken a back seat to business lawyers protecting the interest of the business, and politicians bow to the offers of interest groups that seek to advance their agenda instead of the peoples'. These one-sided approaches away from the needs of the people have led to an apathetic system of capitalist abuse on humanity.

A philosopher of their own, G.W.F. Hegel said, "To widen the market and to narrow the competition is always the interest of the dealers ... The proposal of any new law or regulation of commerce which comes from this order, ought always to be listened to with great precaution, and ought never to be adopted, till after having been long and carefully examined, not only with the most scrupulous, but with the most suspicious attention. It comes from an order of men, whose interest is never exactly the same with that of the public, who have generally an interest to deceive and even to oppress the public, and who accordingly



have, upon many occasions, both deceived and oppressed it." - The Wealth of Nations, Book I Chapter XI.

The wealthier and more powerful the rich becomes, the harder it is for the people to live and the more unfair the law, government policy, and social stigma becomes. When people are pushed to the point of desperation, they will resort to criminal behavior, either street or white collar. However, the most shrewd business man will capitalize on this new-found criminal behavior as a market within the greater society, such as America have resorted to today via the prison industrial and predatory lending systems.

As the divide grows and the people become poorer while the wealthy get wealthier, the middle class is disperse either one way or the other. Those fortunate enough to gain access to the money will eventually move into wealth and power while the unfortunate take a back seat to poverty and under-development. The government, meanwhile, is composed; of course, of members of the wealthy party thus the policies are made to protect the interest of the rich.

From that point, laws are made and enforced against the lower end of the social order and many people become potential criminals, despite the unethical criminality running rampant from the upper end of the wealthy entourage.

Hegel goes on to say: 'The government should do all in its power to combat this inequality and the destruction it brings in its wake. It may achieve this immediately by making it harder to make great profits. If it does indeed sacrifice a part of a class to mechanical and factory labour, abandoning it to a condition of brutalization, it must nevertheless preserve the whole in as healthy a state as is possible. The necessary or rather immediate way to achieve this is through a proper constitution of the class concerned.' - G. W. F. Hegel, System of ethics - Marxists.org/archive/.

The United States government, run by Ivy League alumni and wealthy business owners, are completely out of touch with the average working family. They assume that trickle down economics reach the bottom rungs of society but in reality it never does. It gets caught and suppressed somewhere between small business budgets, state governments and universities, and white collar criminals sanctioned by unresponsive government policies made to protect the business class.

All those living below the state, working for small businesses, and not attending state or private universities never see a dime of that wealth, and are left, and have been left, to feed off the bottom of the social food chain. The urban areas are the worse with underfunded schools, second hand and second rate predatory community businesses that drains what little money the urban residences earn, and businesses that pay little and distribute the filth of immorality to its community.

When voices from those communities cry out for help, they are silenced before reaching the people who actually need to listen and hear their cries. Government stopping blocks are put into place to ignore the urban and rural voices yet open only to the needs of society's so-called suburban middle class citizens, the ones who have become debtors to the area banks, lenders, or who are government owned or funded.

Notice that during the 2008 campaigns, all the candidates referred to the American people as "the middle class." They never talked about the working poor or the poor, that is because those who are actually having taxes taken from their pay checks are considered citizens worthy of government attention.

Many lower-income workers are tied to a child tax credit and have no taxes taken from their pay checks simply because their wages do not meet or exceed the government standard poverty line. Most families earning less than \$30,000 a year are finding it harder to afford the American dream, no matter how hard they work or save. Everything is unaffordable and one pay check out of financial reach, including college, new car purchases - which would establish a credible line of credit - or neighborhood starter homes. With banks tightening lending standards, it has become harder for the working poor to excel.

However, instead of launching billions of dollars in bailout money to encourage businesses to return to the States or to reopen in urban and rural areas, or to better educational institutions in economically deprived areas of the country; or throwing billions of dollars toward community reformation and revitalization, encouraging stronger families, which make stronger communities, or devising an alternative credit institution for the working poor aside from the higher, more stringent lending institutions, or even restructuring the credit system with a "New Start Program", the United States have no intentions of helping the poor to overcome but have all the intentions of helping the rich to excel.

Greed, stinginess and the lack of intelligence within the United States government trickles down throughout the Ivy League campuses to top-level management in large corporations to major media outlets through to Hollywood and all other major industries in the country and have spread like anthrax to the American people, because the people have become just as lackadaisical and selfish as the leadership in knowing how to discern between right and wrong, good and bad, and distinguishing between their left and right hands.

A society cannot function on a capitalist base unless the bottom rung is supplied with the tools they need to fuel the economic engines. If workers are not healthy enough to perform or not being paid enough to keep up with the cost of living, then the standard of living and the people's health will deteriorate. If the people cannot work and are dependent on medicines to do so, eventually, they will fall sick and cost more. As long as the pharmaceutical companies are making money, they do not care about the health of the workers, but it will eventually cripple everyone in the long run.

The stupidity of policy that outlaws and penalizes citizens by taking away their privileges to operate as normal citizens is unproductive and idiotic. Government courts and individualist movements and programs that break-up families causing misery, depression, and distrust among people; lawmakers and policies guarantee the future destruction of a generation of workers. By imprisoning, probating, and aborting, society guarantees a missing and dysfunctional generation. By rewarding deception, cover-ups, bribery, favoritism and privilege to the few, society is destroying the meaning of personal responsibility and merit, yet has the audacity to lay the burden on the poor whenever they want.

When leadership lies, deceives the entire nation, allow the rich to profit and the poor to suffer then turn and blame the poor for their plight; when leadership willingly and knowingly protect the interest of their own while neglecting the needs of struggling families with children and turn and blame that family for their struggles; when leadership does not provide equal opportunity in certain areas depriving certain people of their God-given right to success and liberty, then that leadership is not leadership at all, but are oppressors of the ones they ignore.

So the last shall be first, and the first last: for many be called, but few chosen" (Matt. 20:1-16).

The moral is that it does not matter who put in the most time or who did the most work, it is that everyone agreed to be paid the same amount. Capitalism works the opposite, contrary to the Word of God and the practice of Christianity. Capitalism says, the amount does not matter, what counts is who is considered worthy of the most. Based on this theory, someone has to end up with nothing.

The middle ground for America would be to break the cycle of wealth economics and begin a structure of equality economics. Starting with bringing business to all areas of the country and not just suburbs and financial districts, but to urban and rural areas where factories once thrived. If the community is not working, it will cost more to maintain and eventually lead to poverty, sickness, and corruption.

## **Taxpayers Money in the Hood**

When listening to news anchors, economic and political analyst and comments from the average citizen about "our tax dollars" and where they are being spent, one would think that the biggest burden on taxpayers are the poor and underprivileged by way of government entitlement programs, which in traditional American society usually points to Black folks. As a result, white America - and some Blacks - believe that Black folks are essentially to blame for America's rising tax on the working class and recently to blame for the entire economic crash of America's financial system.

Black people have been the scapegoat for whites since the time they were considered chattel because it is easier to blame ones problems and failures on someone considered unworthy or burdensome, and

especially those who cannot defend themselves against such claims. However, since the mythical advancement of race relations in the United States, Blacks are not completely being blamed any longer, but other minorities, illegals, and poor people have become the target.

As of this day, defenders of "our tax dollars" are browbeating anyone they consider a burden to society by receiving public assistance or government funding, such as the California woman who already has six children and who gave birth to eight more children by In Vitro Fertilization - a scientific discovery they initiated - as a means of making a point about people who abuse the system by draining government of tax money. But such claims only reveal the selfish and stinginess of elitist who would just as well punish or imprison the poor for simply being poor.

To justify arguments for wasted government spending, elitist point first to what they consider entitlement programs, or programs in place to assist those in financial need, such as welfare and Medicaid. And listening to mainstream media one would think if it were not for these type programs, the country would never have a deficit. Instead of focusing on the bigger government spending ventures like military spending, they feel better when they can convince themselves and the public that our problems start and end with the poor, specifically Black people.

When government taxes your check, they are constitutionally responsible for using that money to protect the country against outside invaders, and without a doubt, this is the number one reason for government spending, not entitlement programs. But this argument is never used when elitist talk of government spending because they would rather dodge responsibility and place blame on the weaker of the people.

"U.S. military spending - Dept. of Defense plus nuclear weapons (in \$billions) - is equal to the military spending of 15 countries combined.

These numbers show military expenditures for each country. Some say that U.S. military spending will naturally be higher because it has the highest Gross Domestic Product (GDP) of any country. The United States accounts for 47 percent of the world's total military spending, however the U.S.'s share of the world's GDP is about 21 percent. Also note that of the top 15 countries shown; at least 12 are considered allies of the U.S. The U.S. outspends Iran and North Korea by a ratio of 72 to one." Warresisters.org.

Instead of browbeating government officials, Congress people and state representatives about the massive amounts of spending on military, they take the cowards way out and beat on the poor. This is typical. They use phrase like, "our tax dollars are funding state welfare and food stamps," and "I am tire of paying for poor people to live," and "they are taking my money and using it to help people who do not want to work."

These arguments have very little to no validity when compared to where our tax dollars actually go. They talk as if each day, someone from the government approaches them and reaches into their pocket to pull out three dollars. They talk as if they get off work and stop by the state welfare office to drop their three dollars into the cup.

In reality, they are not personally funding someone on welfare no more than they have paid for the semi-automatic weapon or the guided missiles to kill an innocent family in another country. In reality, the few dollars or cents they have contributed to a poor family in America via taxes cannot compare to the misery, pain and suffering they have contributed to in places around the world for the past 100 years.

## **Government Spending**

In fact, the money being used from any one persons check to pay for government assistance is not even a third of what is used for defense. A person's state tax is always far less than their federal tax. The federal tax is used for military while their state tax is used for state spending.

But cowards will not complain about, publically humiliate, or even begin to get angry at their officials but instead take their frustrations out on the poor. A seriously hypocritical and stingy nation America has become. They would rather fund killing and maiming instead of assisting the poor.

## **State Spending**

"According to the most recent edition of NASBO's State Expenditure Report, estimated fiscal 2008 spending from all sources (general funds, federal funds, other state funds, and bonds) was approximately \$1.55 trillion, with the general fund representing 44.3 percent of the total. The components of total state spending for estimated fiscal 2008 are:

- Elementary and secondary education, 20.9 percent
- Medicaid, 20.7 percent
- Higher education, 10.3 percent
- Transportation, 8.1 percent
- Corrections, 3.4 percent
- Public assistance, 1.6 percent
- and all other expenditures, 35.1 percent, which may include the following:
  - Grants to municipalities
  - Employees' retirement system and health insurance
  - Unemployment insurance
  - Workers compensation
  - Public welfare
  - Lower and higher education instruction programs
  - Children and adult mental health and correctional facilities.
  - Debt service
  - Department of Rehabilitation Services

Medicaid accounted for 20.7 percent of total state spending in fiscal 2008 and is slightly less than the amount budgeted for elementary and secondary education, which in fiscal 2008 is estimated to be the largest single portion of total state spending." Nasbo.org.

So if a little more than 20% of state spending is used for government entitlements, the rest is used for expenditures that we all use and or benefit from. This amount would equate to mere pennies a month for any one individual, which is not even worth mentioning. The problem, of course, is that elitist cannot seem to bring themselves to talk down about their failures but feel better about themselves by discussing and blaming the poor. In fact, instead of complaining about any of the other expenditures, they focus on welfare and Medicaid just so they can point to the poor - Blacks in particular - even if facts state that the welfare state is made up of majority white folks and not Blacks. This is shameful and a smear on the integrity of supposedly decent and so-called educated people.

In comparing the cost of inmate incarceration as opposed to a welfare recipient (who is predominantly white) the costs are similar in total spending. However, they will complain about spending on welfare but not on the cost of incarceration. The reason is because they do not care about how much is spent on the prison system because the inmates are mostly Black and Hispanic. But if the inmates were mostly white, they would certainly find a way to decrease the cost and somehow rehabilitate the inmates. But that is not the concern because prisons are filled with Blacks.

They would rather not "give" anything to the poor via welfare entitlements but have no problem spending just as much to "give" a prisoner a place to live or to fund world murder. What hypocrisy. "Operating costs averaged \$22,650 per inmate in fiscal year 2001... The increase in cost of corrections outpaced the cost of health, education, or natural resource; State spending for corrections increased from \$65 per resident in 1986 to \$134 in 2001. Per capita expenditures for State prison operations alone rose from \$49 in 1986 to \$104 in 2001." Ojp.usdoj.gov.

State spending on education is the only other cost higher than welfare entitlements but we all know that schools in the urban areas hardly see a dime of that money because most of it is used toward suburban schools and white communities. So by depriving the poorer areas of decent schools, they are increasing the risk of criminality and joblessness. In addition to being deprived of public money, poorer areas and municipalities are taxed at the same rate as other areas in any state. In terms of revenue:

"In fiscal 2009, states enacted net tax and fee increases of \$1.5 billion. The largest enacted increase was in corporate taxes (\$1.36 billion), while states also enacted increases in fees (\$805.2 million), sales taxes (\$676.8 million), cigarette/tobacco taxes (\$270.6 million), motor fuel taxes (\$67.7), and alcohol taxes (\$7.5)." Nasbo.org/Publications.

Corporations are given larger tax breaks by relocating to lower tax counties, which are predominantly white areas, while more corporations leave the inner cities to avoid the higher tax rates thus bringing greater levels of poverty to those areas. So when suburban residences can find no other reason to complain about taxes other than government entitlement programs, it shows their complete refusal to face or admit the inequalities in the overall tax structure and by what ways we are taxed. Nevertheless,

government leadership in state and local municipalities is never held accountable for the mismanagement of state funds.

Blaming the poor for America's financial problems has become an easy out for the elite and rich. Talk about double standards. The truth, statistics and facts have no place in their claims, but they commercially apply age-ole stereotypes to their reporting on public airways. Because of this denial, no problems will ever get solved but only ignored and grow worse. White guilt and racism is the true cause of America's financial problem because instead of laying the blame on where it should be, military conquest and attempted world domination, whites feel better about blaming the poor, Blacks in particular.

Rarely does one hear Black folks complaining about where "our tax dollars" are going, and if one does hear it, it is only a pretentious characteristic of "acting white." Blacks already know and have always known where our tax dollars are going. We know they go to military spending, world wars and the white communities, are we are not gullible enough to believe otherwise. So let it be known, taxpayers money is NOT in the hood.

## **Insurgent Whites Declare Open Season on "Niggers"**

If you have not noticed, young Black men are being killed and unjustly persecuted by law enforcement authorities, militia hate groups, and roaming bands of white assassins throughout the United States; and if this does not bring a cold chill to your bones, the white media and United States Justice system have all but publicly sanctioned this national fear campaign against Black Americans.

We will not be as so conventional to draw back to slavery or the Jim Crow terrorism that plagued the country, but we will go back as far as a decade for a starting point of this campaign. For instance, the 6-year old Black child in Florida who was apprehended and handcuffed by a team of St. Petersburg police officers; the 70-year old elderly Black woman in Atlanta whose home was raided as she sat in her chair, shot and killed by officers, and the recent incident in Jena La. that testifies to the fact that the justice system is the backbone of it all.

But nothing can more of a testimony to the hatred of this campaign than the blatant killing of Black men by police officers.

Over the past decade, numerous Black men have been killed in what the media would suggest are justified killings by police officers just doing their job in the face of dangerous Negroes. However, evidence has told more often than not, that the killings were in fact, not only unjustified, but heinous murders committed by power-possessed white officers and [Black] blood thirsty white vigilantes.

The media have obviously made it a point to conceal most evidence and fact, choosing rather to turn the tables from white hate to Black pathology. They attempt to blur the scales of injustice by heightening the incidences of Black men who kill each other as opposed to the number of them killed by white cops, but the scales come clearly into focus when one considers that the white officers are representation of United States justice and should be held to a higher standard.

For example, kids fight among each other all the time: in school, at home, on the playground. Also, parents abuse kids all the time, but the number of parents that abuse kids compared to the number of kids that fight among themselves is considerably less overall, in addition, parental abuse is a far greater heinous act than kids fighting.

Not to diminish the seriousness of Black men killing each other, but we must realize the fact that police officers who kill Black men is far more serious. Abusive parents need psychological help and likewise police officers that abuse their power on the public.

Now if Black officers were killing Black men, then we would have scientific reason to believe in this so-called Black pathology because we would have to come to grips with the fact that Black men simply hate other Black men. But this is not the case, especially when judges and the courts are playing a large part and have decided to defy the Constitution and Bill of Rights to practice injustice toward Blacks by filling the prisons with them. Any reasonable mind has to question this so-called logic and balance of justice.

We now know that there are no reasonable minds in white America. So we cannot continue to remain passive in this obvious covert war on our people. Because there is no real Black leadership, and because protests, marches and political campaigns have not stopped these killings, we must fight back by either arming ourselves against this violence or organize a world crusade against the United States' terror campaign on Black people.

Neither can we continue to accept this false notion that because we decide to take up arms against police terrorism that we are feeding the problem. This concept is obviously not a daily part of police thinking so we cannot allow them to disarm us while they continue to arm themselves and murder us. The media can and will continue to undermine and mask our attempts at defense as counterproductive while continually justifying the insurgency of white terror until we ask ourselves and prove to the world who really has the moral deficiency where it pertains to practicing routine and premeditated manslaughter.

Again, the fact that police officers - sworn to uphold the law - along with private citizens, so-called Christian folk who have pledged to protect their rights and property, are protected under the distorted discretion of the United States justice system when a Black person is found dead, in addition to mainstream media's misleading, indifferent, and vague coverage of this obvious form of national terrorism, confirms that we live in a country that is equal to, if not greater than, a low-level form of a Western holocaust and genocidal structure of ethnic cleansing.

To remain on the safe side, and in order to protect the lives of every Black person in America and not give reason to the white forces to shoot to kill every Black in their path, instead of taking up arms to protect ourselves against such cruelty, we could gather evidence and facts and continue the legal process with a higher authority, such as the United Nations, World Court, or Throne of God, take your pick.

- The most recent and blatant killing of Oscar Grant by BART police officer
- 21 year-old Johnny Goodwid of Chicago killed by police
- Tarika Wilson and her baby killed by police
- New York City cops murdered high school senior Timothy Stansbury
- Gidone Busch, who was clutching a hammer when officers fired 12 times
- The shooting of Amadou Diallo, an unarmed West African immigrant who died in a hail of 41 bullets in addition to Timothy Stansbury, Ousmane Zongo, Patrick Dorismond
- Khiel Coppin mentally ill Brooklyn teen that had a hair brush mistaken for a gun
- Katrina's Hidden Race War of Algiers Point
- A 22-year-old man killed in a police shootout was hit 14 times
- Nathaniel Jones, a 300 lbs Black man killed by police
- Michael Knight and Frisco Blackwood, both killed in a hail of Miami-Dade County Police bullets
- Garcia "BG" Beaugris was brutally shot and killed by Miami-Dade police

- Stories of 15 black men killed by police in Cincinnati alone since 1995

These are just some of the few incidences reported on and known by the public. Who knows how many Black people have been killed, tortured, or unjustly treated by the US civil and legal system in this new insurgency of white American hate? Most have gone unreported from the back alleys, highways and byways of America's cities, towns, and suburbs. And most of these acts the system have ignored, thrown out of court and simply refuse to further investigate, confess or admit to?

Like the hidden sundown towns - that only allow whites to live - we thought were a distant memory of American racism but still exist today, we cannot naively continue to believe that these are the only killings and acts of domestic terrorism committed against Blacks. Only God knows and will someday reveal the level of hate embedded inside the hearts of white America, not only in rebels of race hatred, but in the minds of authority in high places.

## **Why the Poor are Poor**

Biblically, there are three types of poor people in the world: the oppressed poor, the slothful poor, and the irresponsible poor. The oppressed poor are fatalities of the rich. Field hands, workers and laborers that feed the wheels of big industry. Scripture says, "But ye have despised the poor. Do not rich men oppress you, and draw you before the judgment seats?" - James 2:6.

The slothful poor are those who have not come to terms with the realities of life, but who mosey through life and eventually hit the poverty bottom. Scripture says, "Love not sleep, lest thou come to poverty; open thine eyes, and thou shalt be satisfied with bread." - Proverbs 20:13. And the irresponsible poor are those who do not take life seriously. Again, the scripture states, "For the drunkard and the glutton shall come to poverty: and drowsiness shall clothe a man with rags." - Proverbs 23:21.

Statistically, there are more oppressed poor than the other two. The working poor and underclass of society are not all slothful or irresponsible but the slothful and irresponsible belong to every class, in which many are undeserving. When the undeserving gain access to power, it is normally they who oppress because they are unappreciative or simply do not care. However, the oppressed poor are more selfless when they reach power because they understand the plight, unless arrogance takes hold.

When the social elite talk of the poor, they are apt to attach slothfulness as the reason and irresponsibility indirectly, rather than attribute oppression as the reason. If they admit the poor are poor because of any kind of systematic oppression, then they would have to take responsibility for the systems they implement and sustain, but instead, they instill the notion of personal responsibility into the minds of society so the failures of the system cannot be blamed, but the blame can rest on the individual.



If anyone speaks ill against the system and the oppression it dispenses by bringing truths to light, they are considered either as possessing the victim mentality, or unpatriotic and anti-American. Statistically however, there are more people who are poor but not slothful than there are poor because of slothfulness or irresponsibility. The many urban and rural areas testify to the fact that hundreds of thousands even millions of families throughout the country live on, just above, or just below the systematic designated poverty line. Also, the fact that only 1 percent of the country are of the rich and another small percentage are upper class, which would suggest that only a small percentage of the country is completely responsible.

When politicians speak of and make promises to the middle class and upper classes, they want people to believe that they make up the majority of society's working population, but in reality, there are just as many working poor and poor families as there are middle and upper class. The outline below shows the class levels in America:

The wealthy - 1%

Upper class - 9%

Middle class - 30%

Working poor - 35%

The poor - 25%

According to the stats, there are more poor and working poor combined than there are middle class, so why do politicians pander to the middle class and the wealthy when they make promises to the people? Because the American political system is designed to support the capitalist base and its industry and is more interested in increasing wealth for a few than uplifting or empowering the base of the masses who work to make the industries successful.

Like a machine neglected of maintenance, if the machine is not oiled well or often enough, it will eventually fail and not function to its fullest capacity. The systematic state of America today is creating more poor and more rich simultaneously, cutting the middle numbers down and eradicating equality while increasing the upper and lower classes. Soon the outline will look like this:

The wealthy - 10%

Upper class - 20%

Middle class - 10%

Working poor - 25%

The poor - 35%

The more the gap widens, the more the elitist class and the political leaders can claim poverty is the result of the poors' own doings instead of acknowledging that it is the system itself and its cycle of favoritism toward the rich. More opportunities are becoming out of reach for the working poor making it harder for them to lay hold on prospects that would otherwise increase their chances at wealth.

If the rich class continues to grow and the poor increase at the same rate, there is clearly a problem of equality in democracy on many levels. But to explain away the deficiencies of wealth distribution and opportunity, the elitist class refuses to accept responsibility of fulfilling the goal of equality and lay the burden of guilt and poverty on those who have no means to change their circumstances.

Attaching the label of or idea of the poor being slothful or irresponsible as the reason of their poverty while ignoring the practice of oppression is a slothful and irresponsible practice itself; limited in sociological realization and the ability to lead effectively. In the end, because of this lopsided process, the economic foundation of the country - any country - will fall under the weight of greed, and poverty ironically becoming the ultimate end.
